**The terms and conditions for Supply shall be as under:-**

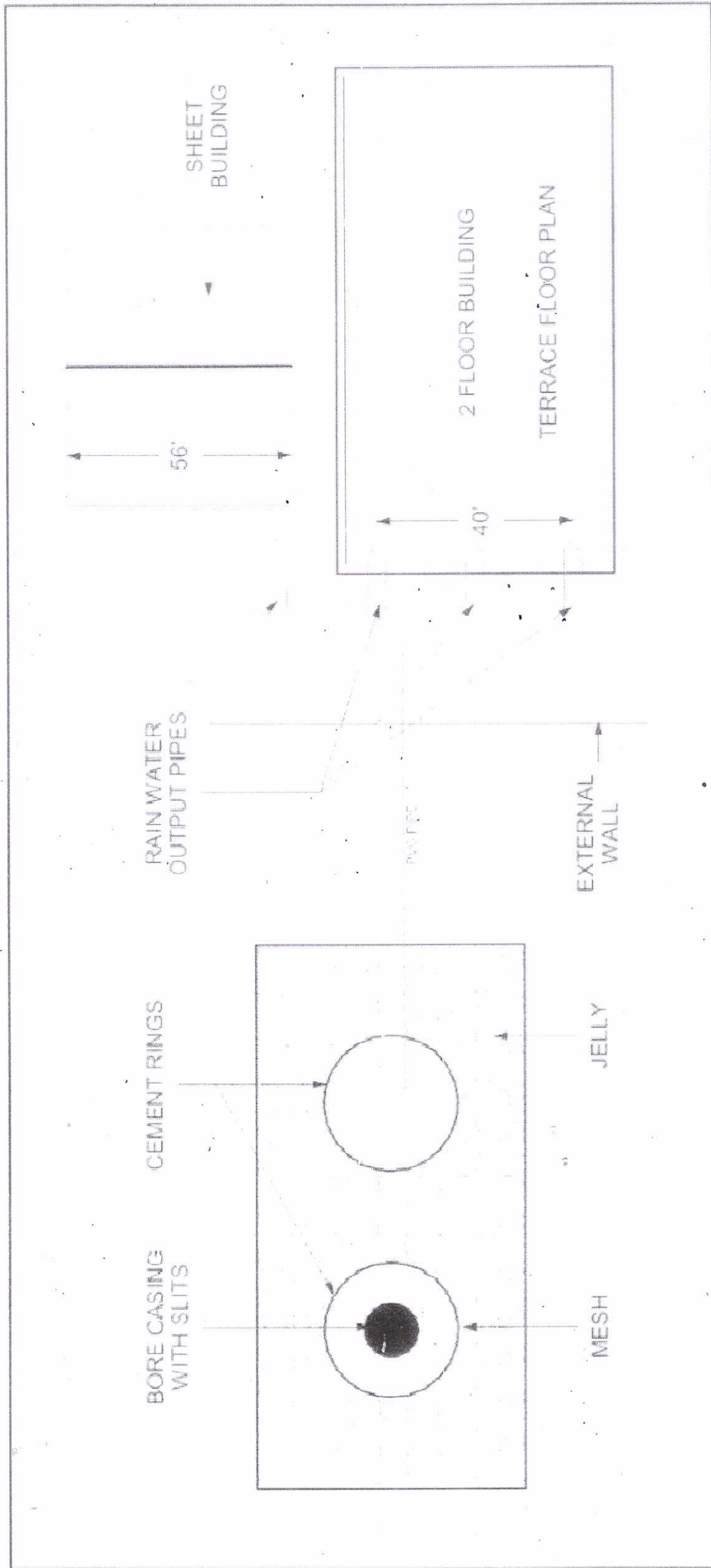

3. The rate quoted shall be inclusive of packing & forwarding charges freight paid for destination Farmagudi Industrial Training Institute, Farmagudi, Ponda- Goa.
4. The quotations shall be valid for 45 days from the date of the opening of the same.
5. The quotation will be evaluated for full Rain Water Harvesting together. Therefore, the rates for repair charges including spares may be quoted together.
